- NALC is the sector body for local (parish and town) councils and councillors run by councillors, for councillors and councils
- Partners with network of 43 county associations
- 10,000 councils, covering 92% of country, 35 million people including 16 million electors
- 100,000 councillors, spending 14 million hours supporting councils and improving their communities
- 3,500 local clerks represented by Society of Local Council Clerks (SLCC)



PARISH PARTNERSHIPS IN ACTION

- Critical areas where our sector can contribute to addressing these challenges include....
- Working with other tiers of local government to support current funding crisis –
 NALC published a <u>call for action</u> with some ideas
- Declare a climate emergency and work with other agencies locally, see our <u>website</u>
- Provision of affordable housing especially in rural areas through neighbourhood planning and exception sites - <u>English Rural toolkit</u>
- Work in partnership with other parishes to deliver services for residents where a critical mass is needed – e.g. community transport or road safety
- Pro-actively promoting good health dementia friendly communities, mental health awareness, tackling loneliness, green spaces and play areas etc.....taking pressure off statutory services such as NHS, social care, youth services



SOME ASKS FOR YOU!

- Demonstrate good governance through the Local Council Award Scheme and signing the Civility and Respect Pledge
- Recognise the scale of the financial crisis and discuss with residents what their ambitions are
- Pro-actively reach out to other tiers and partner organisations
- Look at how you can work with or support other local councils
- Get to know your new MP, invite them to events and tell them what you're up to
- Encourage more people from all backgrounds to get involved in your council



NALC WORKING FOR YOU IMPROVING THE SECTOR: SERVICES

- Advice, guidance and resources exclusive in member's area of NALC website and via county association
- Legal and financial topic notes, briefings and financial briefings including standing orders, financial regulations and practitioner's advice
- Toolkits/guides including on data protection, employment, planning, social media and finance (over 160,000 distributed/accessed)
- Working with Society of Local Council Clerks (SLCC) and others on sector improvement and good governance – 5000 clerks gained Certificate in Local Council Administration, 700+ councils achieved Local Council Award Scheme
- Training and development for councillors via county associations including e-learning

NALC WORKING FOR YOU: ADVOCACY

- Engagement with Government and political parties on NALC manifesto and policy objectives including remote meetings, standards, councillor allowances, funding and more
- Good link/work with LGA and others
- Policy development through Policy Committee, informed by you!
- NALC lobbying has achieved...
- no council tax referendum principles (capping)
- access to £150 million Community Ownership Fund
- exempted from requirement for external data protection officer, saving £3 million
- increased understanding/profile of sector



NALC WORKING FOR YOU: ADVOCACY

- no business rates on public toilets, saving £4 million
- procurement of external audit for councils, saving £4 million
- slowed withdrawal of council tax support funding
- range of pandemic funding and flexibilities for councils (remote meetings and audit timescales)
- new provisions in Levelling Up and Regeneration Act e.g. power to provide financial assistance to church buildings
- Priorities: strengthen standards regime esp. sanctions, allow remote meetings, direct access to government funds, greater respect and awareness of the first tier of local government

LABOUR MANIFESTO

- Missions: economic growth, clean energy superpower, take back our streets, break down barriers to opportunity, build an NHS fit for the future
- Planning reform: housing numbers, green/grey belt, onshore wind, new towns, strategic planning, planning officers
- Finance and audit: replace business rates system, multi-year funding settlements, end wasteful competitive bidding, overhaul the audit system
- Devolution: transfer power out of Westminster, devolving power to communities, legislation to take back control
- Standards: new Independent Ethics and Integrity Commission
- Community safety: Martyn's Law



NALC NEXT STEPS

- Engage with new ministers (re-engage with officials)
- Positive early signs including enthusiasm for engagement, looking at remote meetings, audit changes and neighbourhood planning
- Commission external public affairs agency to help engage with new MPs etc.
- Parliamentary president and vice-president and All-Party Parliamentary Group on local democracy
- Political party conferences in Autumn 2024
- Seek to influence relevant Bills in King's Speech (40c bills)
- Parliamentary reception in February 2025 and Star Councils awards



NALC NEXT STEPS

- Mobilising county associations and local councils, including:
- councils and county associations encouraged to get to know their MPs
- put engaging with MPs on your county association agenda and tell them the brilliant work councils do
- councils encouraged to write a letter of congratulations to the newly elected MP in their area and invite them to a meeting or event and tell them what you do!
- councils invited to include MP details in their newsletters and communications
