#### 2. Approval of minutes of the meeting held on the 10<sup>th of</sup> March 25.

Chair opened the meeting with a minute's silence for Cllr Mike Royds

#### 3. New Secretary

Chair introduced Cllr Greera Stevenson to the meeting, with the hope of encouraging attendance at meetings and new members.

Proposed: Cllr Alan Neal Seconded: Cllr Mary Thomas

Cllr Alan Neal explained why he needed to retire as Area Secretary. The Members thanked him for his service and dedication to the Area Meeting.

#### 4. Chair's Report

Chair gave an update on the LALC conference -

Preparing for the Government reorganisation (Devolution) Asset Management was discussed, to encourage parish councils to take on assets that are currently managed or maintained by Borough Councils & LCC. It was discussed how parish councils are supposed to afford these assets and how transfers will happen. This would most likely be done via a nominal fee exchange and an asset transfer. To encourage new parish councils to form where there are none or developing new neighbourhood groups.

Letter to Burnley borough Council -

Chair read out a letter he drafted to Burnley Borough council's chief executive, sharing his concerns over the devolution and the lack of parish and town councils' input and information from the borough. Cllr Alan Neal offered to also contact the chief executive if no response was received.

#### **5. Reports from LALC Executives**

NALC - Cllr Alan Neal (exec) discussed his experience at the NALC conference, and the parish and town councils place in the devolution process. NALC are pushing for the parish and town councils to be involved in the process.

LALC - Cllr Alan Neal explained the finance committee and scrutiny committee is delt with by members of the management committee and executive members. He also felt that the new Chair of LALC was met with hostility.

It was felt that borough councils are worried about their place in the devolution during discussions on merges with borough's. worries that the newly formed authority will take most of the funding, leaving parishes to put up their precept to survive, emphasizing the need to engage with parishes. Discussions on a sliding scale for asset transfers giving parish/town councils time to raise funds and sort the running of new assets.

President was removed for non-attendance at meetings, so a new president is sought. Cllr Alan Neal has proposed a 3-year term instead of the forever position as is now.

12 august 25 there is an extraordinary meeting for the finance committee.

It was felt that NALC & LALC are male oriented, probably as it was established post war.

Alan to share all contact details with the new Area Secretary.

#### Concerns for members

To ensure parish councils are aware of government reorganisations. Need to know what conversations are being had at higher levels. To ensure parishes are aware of asset shifts.

#### 6. Reports from parishes

#### Cllr Alan Neal (Whitworth TC)

Market street accident leading to a fatality. The council has been incidental in trying to resolve traffic problems in relation to Market Street. There have also been issues with Tunnicliffe Road.

Secret Park – was taken over by the town council and being refreshed & renamed as Mike Royds memorial park.

Noncompliance by parish and town councils to regulations by 2026 can be fined up to 100k.

Plan submitted – reg 16 to do with neighbourhood plans. It is with the examiner, pre-referral report already done, amendments suggested by the examiner.

The rough is trying to obtain planning, but this affects the local plan/neighbourhood plan. New government has doubled the amount allowed but hoping it comes under the pre new government rules.

No funding for neighbourhood plans anymore.

Discussions over grey land planning, building on old coal mines is not allowed and has stopped some builders. Borough decides what kick back money is spent on, unless parish and town councils demand it is spent in the area. All Whitworth councillors have moved over to (.co.uk) emails as having trouble with the (.gov) emails at the present time.

#### Cllr Mark Jinkinson (Worsthorne with Hurstwood PC)

Hurstwood Green—Phase one of the refurbishment to Hurstwood green for the benefit of residents and visitors has been completed. The track bed was in a bad state but has now been resurfaced along with measures to manage parking on the track. The PC is hoping to obtain a grant for phase two of the project alongside a partnership with united utilities. This will deal with the surface water management to includes 'swales' and a small pond. Approximate costs 17K.

The lower Allotments on Gorple Road need more water access, there is a possibility of rainwater collection into a pond to avoid extra charges.

## Cllr Mary Thomas & Cllr Howard Thomas (Pendle/Colne TC) Vandalism problems (Atkins coat Park).

Eco friendly houses built, but residents seem to be causing problems.

Trying for holiday schemes for residents' children.

Santander offering banking help following the loss of bank branch, they are going to try and approach bank of Dave.

Cllr Alan Neal offered to approach bank of Dave to see if a banking hub can be arranged.

Lots of events in Colne and worry that there are no banking facilities to support.

Blues festival approaching, this is a 3-day event.

Food and drink event this Saturday.

GB cycling professional event this weekend.

#### 7. Issues Raised
